**Ans:** Yes, If you have indicated your current employer details in NSR, your current employer can view your NSR profile and confirm your employment details, this makes your profile verified.

**Ans:** Your current company can confirm your relieving date, upload the background check report but cannot post any performance related comments for the same.

#### Q. Can my Ex - employer view my profile?

**Ans:** No, when you update your profile with your new employment details your Ex-employer will automatically cease to have access to view your NSR profile
