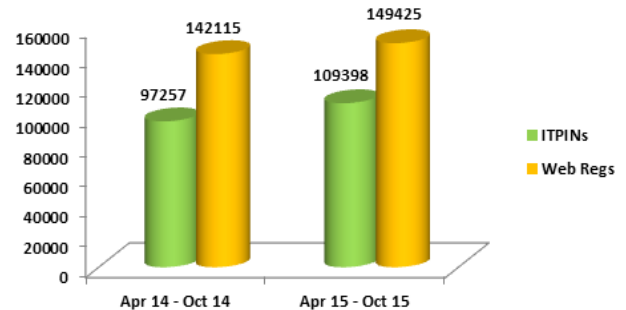
190 companies have joined NSR. 18 new member companies have enrolled for NSR membership in the current financial year - 2015 – 16.

Two new background check agencies have been empaneled on NSR.

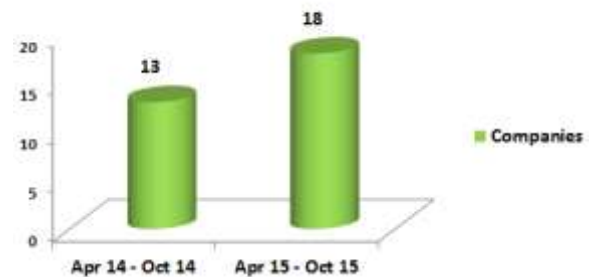

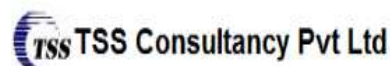

## Facilities available for Subscriber Companies



**Search and View** unique biometric based profiles of your employees and non – employees who have given permission to your organization to view their profile. You can search and view profiles using your NSR member company login. You can view photograph, personal details, educational details, career information and background check results of registered professionals.



Confirm the joining details of your employees (**Link**) like employee code, date of joining, and joining designation on NSR. Such linked information cannot be changed by the employee and is equivalent to employment verification. You can also confirm / update the relieving details (**D-Link**) of your employees like Relieving Designation, Relieving date and update Relieving comment. Create a **self-sustaining system** for you and your industry by following this practice.



**Conduct Background check** on profiles of your employees / non-employees. You can select the fields to be verified and allocate the details to an NSR empanelled background checker (EBC) of your choice. Background check results will be displayed on the profile of the candidate and the details once verified cannot be changed by the candidate.
